- §780-403.B. Final plat, in accurate and final form for recording.
- §780-403.C.1. Final site development plan, including all required information and demonstrating compliance with the applicable standards and regulations of Article V.
- §780-403.C.2. Final grading plan, including all required information and demonstrating compliance with §780-503.
- §780-403.C.3. Final stormwater management plan, including all final calculations.
- §780-403.C.4. Final soil erosion and sedimentation pollution control plan and evidence that the Allegheny County Conservation District (ACCD) has issued a finding of adequacy.
- §780-403.C.5. Dimensioned site layout plan.
- §780-402.C.13. Final photometric plan, including all required information and demonstrating compliance with §780-402.C.13.
- §780-403.D.1-9. Construction Plans for Public and Private Improvements, drawn at a scale no smaller than 1" = 50' on sheets measuring 24 inches by 36 inches, and containing all required information.
- §780-403.E.1-6. Permits and approvals. The applicant shall provide certified copies of all required permits and approvals.
